Treasurer Report: Gary provided a summary of the financial position in the Treasurer's business report.

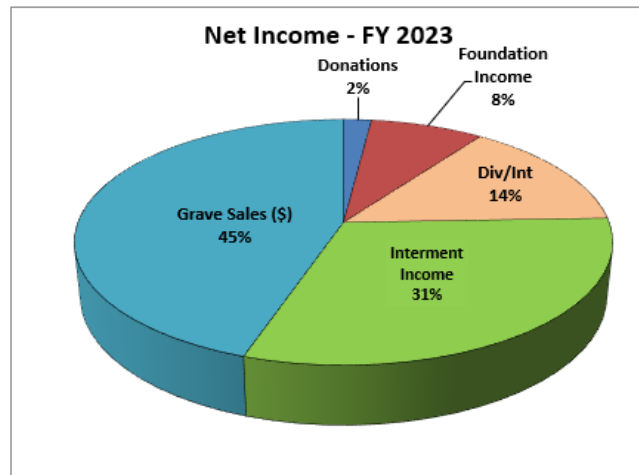
